- The ADC works to increase, maintain, & diversify the tax base; in 2023, ADC clients pay over \$1,000,000 in property taxes and have a tax-assessed value of over \$132,000,000.
- The ADC focuses on the economic diversification of the business community; Aberdeen has the 9th most diversified economic base of all 542 Micropolitan Statistical Areas in the US. This is significant because a region with high industry diversity can signal economic stability and more easily withstand economic pressures.
- At the heart of almost every initiative the ADC undertakes is a focus on driving up Gross Domestic Product receipts, creating and retaining jobs, increasing per capita income, and ensuring regional self-sufficiency in the face of state and federal budget challenges.
- The ADC annually conducts over 200 Business Retention & Expansion visits. These visits build robust relations with businesses, allowing the ADC to encourage businesses to continue to make investments and flourish in our community.
- The ADC represents our community and regional interests through a focus on advocacy and lobbying at the local, state, and federal levels. The ADC operates a Public Policy Committee in partnership with the Aberdeen Chamber of Commerce. Recent successes are:
 - Housing Infrastructure--We were privileged to be part of the SB 41 coalition to further clarify the \$200 million in housing infrastructure funds.
 - o Property Tax on economic development organization land--SB 120 passed.
 - o **Child Care**--Grants for start-ups and expansions of childcare, health coverage for childcare staff, and additional childcare workforce.
 - Workforce--There are several workforce issues and investments made that are key for our economic development infrastructure. Among them are the tuition freeze at our post-secondary institutions.
 - Support for other major economic development investments--We supported a \$13 million investment in the Sanford Underground Lab and the funding of the Small Business Development Centers and Manufacturing and Technology Solutions Programs for our State.
